TERMS OF SERVICE

1. Alpine Green Experience Srl owns the vehicle covered by the service and **discretionally provides the vehicle** depending on availability.
2. The car is insured with **Fully Comprehensive** automobile liability insurance, **including** for theft and fire risks. The user **accepts and** authorizes the **installed** GPS tracking and **black box** monitoring **system via** satellite **for the duration of the service**.
3. **Theft: in the event of theft**, the user must immediately report the theft to the competent authorities. **The police report must be sent** to Alpine Green Experience Srl within 24 hours of the event. **Any** possible excesses, reimbursements, etc. due to **express** limitations of the insurance contract, **as** assessed by the insurance company against Alpine Green Experience Srl in relation to the indemnity of the stolen vehicle, will be exclusively charged to the user.
4. **Passive accidents (not user's fault)**: in the event of a passive accident, the user must provide Alpine Green Experience Srl with all the related documentation and in particular the agreed motor accident statement within 24 hours of the event.
5. **Active accidents (user's fault)**: these accidents are covered by the **Fully Comprehensive insurance** policy. **This policy has an excess charge of €500.00**, which will in **any case** be charged exclusively to the user.
6. **Fines**: **all fines** will be charged **directly** to the user who, **in signing this agreement, accepts that all such fines will be charged to the above credit card**.
7. **Upon the signing of this agreement**, the user declares that he assumes all **civil and criminal liability** deriving from the use of the vehicle, **indemnifying** Alpine Green Experience Srl **against** any request and/or claim of any kind **by** anyone made in connection with **the** use of the vehicle covered by the requested service.
8. The authorization to use the car **may** be revoked at any time by Alpine Green Experience Srl, **including** by verbal communication. **The user is consequently obliged to** return the car **with immediate effect**.
9. Any dispute relating to the execution and/or interpretation of this authorization **will be adjudicated exclusively under the** jurisdiction of the Court of Turin.
10. Unlimited mileage. Charging the car at the accommodation where you are staying is free. The car must be returned **with the reserve generator fuel tank, full**, as it was at the **time of pick-up**; if **the tank is not full, the petrol** will be charged to **your credit card**.

11. Please note that smoking, eating and drinking in the car is strictly prohibited. Failure to comply **the cleaning costs** of € 40.00 **will be charged to your credit card**.
12. The user (and the cardholder if different) expressly authorizes (both authorize) the **deduction of the charges incurred with specific reference to** points 3, 5, 6, 10 and 11 on the credit card communicated at the **time of booking or that** which is attached **to this document** with a signed photocopy of the front & back, together with a photocopy of the holder's ID.
